## **Health Insurance Open Enrollment**

This is an important time of year to review your coverage, learn about the benefits offered, and to add or drop coverage for yourself and/or dependents. You may change plans at this time.

You must apply before April 26, 2024 by the end of the day.

#### 1. Excellus Health Insurance

- · Lewis County PPO Plan for employees hired before November 1, 2022.
- *Hybrid (also a PPO)* This plan offers the <u>same</u> coverage but for lower premiums with slightly higher co-pays, deductibles, and out-of-pocket maximums.
- · *High Deductible Health Plan (HDHP)* This plan offers the same coverage, premiums are even lower, but the deductible is high.
  - \* **HSA** Employees will be eligible to make Tax Exempt payroll deductions and earn contributions that can help meet your deductible.
  - \* Annual limit for Single Coverage is \$4,150, Family/2 Person Coverage is \$8,300.

#### 2. Dental Insurance

- · CSEA Sunrise Dental-available to all employees
- · Guardian Dental-available to all employees

#### 3. Vision Insurance

· Vision administered by CSEA EBF-available to all employees

#### 4. Opt Out of Insurance

- Employees who are in a position that is eligible for health insurance but who choose not to enroll in the Lewis County Health Plan (and are not enrolled as a dependent on the plan elsewhere) or those employees who want to cancel their existing health insurance coverage, will receive a monetary amount (please see your contract) on an annual basis. This payment is postpaid into quarterly installments in March, June, September and December.
- · If you choose to opt out at this time, your first payment will be September 12, 2024.

#### 5. Flex Spending-allows you to set aside money, before taxes into:

- · Medical Care Reimbursement-The annual maximum contribution amount is \$3,200.
- Dependent Care Reimbursement-The annual maximum contribution amount is \$5,000.

#### Remember:

ALL changes must be made by April 26, 2024!



The March 2024 Employees of the Month are JoEllen LaFontaine and Keith Bates. JoEllen is a Licensed Practical Nurse at Lewis County Surgical Associates, and Keith is a Family Nurse Practitioner at Lewis County Family Practice.

A patient nominated both employees for through Human Resources to express his sincere gratitude for the care he received.

According to the patient, "Twenty-two years ago, my wife and I were in a terrible motorcycle accident. The Lord put some competent people in

our path who used their gifts to save our lives. You would think once would be enough! They took many parts out of me, including a kidney; my other kidney healed and has served me well since."

Last summer, the patient was installing a new roof on his house; it was very hot, and he was dehydrated. He had a consultation with a surgeon at Lewis County Surgical Associates. The nurse took his vitals and said they were okay but asked him if he was alright. The patient told the nurse he had been working hard and was very tired but assured her he was fine. She asked if I could walk across the parking lot, and the patient replied yes, but I might have to stop and rest.

The patient started to leave after the consultation, but the nurse had other plans. When he got to the nurse's station to check out, she asked if "I would forgive her as she had called upstairs and asked the provider to see me before I left. I told her I did not have a family provider, and she said I would have one before I left. I said I did not have an appointment, and she responded that the provider did not care. The provider examined me and asked me to go to the Emergency Room. I said I am not going to do that. He then asked if I would go downstairs to the lab for a blood test and not leave until I saw him in half an hour. I completed the blood work and waited to see him again. He told me that I only had one kidney, and it was operating at only 30%, and my internal organs were already starting to shut down. He begged me to go to the Emergency Room. I tried to reason with him and said I would go home, drink lots of water, and rest. He responded, if you do, you'll never make it back to the Emergency Room. If you go to the Emergency Room, I will stop to see you when I am done seeing patients. The Emergency Room admitted me. I was in the hospital for two days to rehydrate and flush my kidney. Now, I am up to 51% and holding my own because these employees love their jobs. Thanks to their professional attitudes and willingness to go the extra mile, I am alive today!"
